BUILDING PERMITS REQUIRED

Often residents wish to update their homes both inside and outside. Perhaps they want to "refresh" a bathroom or install central air conditioning, even wishing to put a fence in their yard or needing a new roof. All of these projects, and many others, require a permit from the village before work can proceed. Residents who renovate without first securing a permit are subject to legalization fees. For your reference, our Village Code can be found on our website, which details which projects require permits and any special rules associated with each. Should you have any further questions, we encourage residents to contact the Village with questions regarding any building project before proceeding.



BAXTER POND GARDEN PARTY HONORING NANCY A. COMER

The Baxter's Pond Foundation held a Garden Party at the home of Laura and Chris Ficalora to honor outgoing president Nancy A. Comer. Local officials, including State Senator Anna Kaplan, State Assemblywoman Gina Sillitti, Town of North Hempstead Supervisor, Jennifer DeSena, Town Councilwoman Mariann Dalimonte, Dave Franklin representing County Executive Bruce Blakeman, and Mayor Nora Haagenson were there to present citations to Nancy and to honor her for her dedication and service to the community.

The late Nassau County Legislator, Barbara Johnson (mother of Craig Johnson, Baxter resident and former State Senator) had seen the park deteriorating throughout the 1990's and fought for funding to completely renovate the park and the pond. A massive renovation was completed in 2001, at which time the park was

re-named Barbara Johnson Park and preserve in her honor. However, the County had no money to continue maintaining the property, which quickly reverted back to an eyesore.

In 2003, Nancy co-founded Baxter's Pond Foundation with the late Carolyn Mandel to maintain and beautify the pond and the immediate surrounding areas. The non-profit foundation relies on donations from private citizens as well as grants to fund their work.

Nancy Comer served eighteen years as president and thanks to her vision, the park looks beautiful today. The cottage on the southwest corner of the park has been dedicated by Nassau County in her name. The park is a great source of pride and pleasure to Baxter Estates residents, visitors, and all who pass by. In January 2022, Kim and John Keiserman took over as co-presidents to continue the

NEW YORK'S ENVIRONMENTAL BOND REFERENDUM AND BAXTER BEACH

In November 2022, New York will have an Environmental Bond on the ballot for the first time in 26 years.

This bond is intended to "preserve, enhance, and restore New York's natural resources and reduce the impact of climate change." Money will be allocated towards flood restoration and risk reduction, climate change mitigation, open space land conservation, and clean water infrastructure.

This bond is important to Baxter Estates and the hope of stabilizing our beach which I have been actively promoting since I was first elected mayor in 2015. I lobby everyone in government on behalf of our beach. I have been told that because our beach area is small, it is not seen as a priority. Yet, we have seen Shore Road flood

during storms with water rising over the sidewalk and into the road creating a hazardous situation. We have seen cars stranded in deep water on Shore Road, needing to be rescued by the Port Washington Fire Department. We have observed firsthand the erosion occurring on our beach. In many places along the sidewalk the beach is less than an inch away from the sidewalk itself. The entire area needs restoration. Assemblywoman Gina Sillitti has been working on our behalf. She is encouraging everyone to vote in favor of the Environmental Bond in November as she believes that this could help us. Anything that offers help to us is worth supporting. Meanwhile I keep fighting for us.

MAYOR NORA HAAGENSON ELECTED PRESIDENT OF THE NASSAU COUNTY VILLAGE OFFICIALS ASSOCIATION

On Thursday June 30th, Mayor Nora Haagenson was elected President of the Nassau County Village Officials Association (NCVOA). Founded in 1925, the Nassau County Village Officials Association is a not-for-profit organization comprised of and representing all of Nassau County's 64 villages and 475,000 residents. It was established to encourage and stimulate cooperation among its member villages for their mutual benefit and welfare. NCVOA works alongside the New York Conference of Mayors (NYCOM) to monitor state legislation and funding to villages and the impact that can have on the residents of Nassau County. It is a valuable resource for Nassau County villages.

REMEMBER TO PICK UP PET WASTE

Picking up after your pet is quick and easy. It is also part of Village Code. Make sure to always bring bags along with you during your walks. Pet waste is a contributor of storm water pollution that can negatively affect our water quality. When it rains, any pet waste left out can spread bacteria and viruses into our storm drains, which lead out to the bay. It has been estimated that a single gram of dog waste can contain 23 million fecal coliform bacteria, which can negatively affect human health. Please be mindful and pick up after your animals.

Also, please remember, DO NOT LEAVE BAGS CONTAINING DOG WASTE ON OUR STREETS OR ON SOMEONE ELSE'S PROPERTY! Dispose of the bag in your own garbage receptacle.

ROADWORK UPDATE

We are happy to report that the paving of Hillside Avenue has been completed. The Village is waiting for the release of funds from the State to proceed with the paving of Bayside Avenue, Locust Avenue, Ridgeway Road, and Woodcleft Avenue. Stay tuned!

LOCK YOUR CAR!

The Port Washington Police District and the Nassau County Police Department have reported a large increase in stolen vehicles in our area. The biggest reason for car theft is people leaving their keys or key fob in their car with the car unlocked. It

takes only a few seconds for a thief to steal a car or remove a catalytic converter from your car. If stolen, your car vanishes in minutes driven to New Jersey where it is put on a boat to be shipped elsewhere. The catalytic converter can be removed in less than a minute and nets the thief \$300. If three or four of these are stolen in a night, the thief earns \$900 or more. Be observant and be sure to lock your car, lock your house, and lock your garage.

PORT WASHINGTON WATER DISTRICT MANDATORY CONSERVATION GUIDELINES

The Port Washington Water District (PWWD) reports that water shortages during times of peak demand are a real concern this summer. In order to meet the water needs of our community during the hotter months, while simultaneously taking wells offline and constructing the treatment systems necessary to address emerging contaminants, the Port Washington community MUST conserve water. With irrigation systems drawing the greatest demand for water, PWWD is relying on residents to take specific actions to save water when irrigating this summer.

To help alleviate the sharp increase in water demand in the early mornings to satisfy the needs from irrigation systems, PWWD has worked with the local municipal jurisdictions to break the peninsula into varying irrigation zones. This coordination will prevent the PWWD's infrastructure from becoming overwhelmed during peak times.



Baxter Estates irrigation is only allowed between 11PM and 1AM. Residents must adhere to Nassau County's Odd/Even Lawn Watering Ordinance or risk facing fines or a summons. It is up to all of us to conserve water. Please visit their

website at www.pwwd.org to read all the Water Conservation Requirements and for information on how to receive a \$150 rebate through their Landscape Irrigation Smart Controller Rebate Program Application.
